#### CONFERENCE OPENING SESSION

## PANEL DISCUSSION "WHY DO WE NEED TO RESEARCH THE FORMS OF THE STATE?"

November 7, 2023

Moscow, Faculty of Law of Lomonosov Moscow State University

Politicization of scientific research especially affects legal science. However, the categories familiar to several generations of researchers of the state and law are acquiring a new meaning, so there are more and more frequent proposals to revise traditional approaches to the form of the state, or even to reject this category altogether. In the framework of this panel discussion it is proposed to discuss topical problems of the forms of the state, the correlation of the form of government, the form of state-territorial organization and political regime from the perspective of social sciences.

**Participants:** invited Russian and foreign experts (with reports), young scientists and current researchers (without reports as panelists).

Languages: Russian and English (simultaneous translation).

# SESSION "30 YEARS OF THE CONSTITUTION OF THE RUSSIAN FEDERATION: OUTCOMES FOR FEDERALISM AND LOCAL SELF-GOVERNANCE"

November 8, 2023

Moscow, Faculty of Law of Lomonosov Moscow State University

Federalism and local self-government according to Chapter 1 of the Russian Constitution are the foundations of the constitutional system, but the practice of implementation of these norms is far from the generally accepted understanding of the institutions of federalism and local self-government. The thirtieth anniversary of the Constitution of the Russian Federation is a symbolic call for a discussion on the state of Russian federalism and local self-government, their institutional organization and possible prospects. The study of the obvious and hidden meanings of these institutions of Russian constitutional law in the context of other elements of the form of the state will allow us to better understand the logic of further development of Russian statehood.

**Participants:** invited experts (with the possibility of a plenary report), young scientists and researchers (with and without reports).

### SESSION "HISTORY AND THEORY OF FEDERALISM"

November 9, 2023

Moscow, Faculty of Law of Lomonosov Moscow State University

Studies of the history and theory of federalism are deeply interconnected and interdependent. The historical context influences theoretical approaches to state building in the same way as theories embodied in practice predetermine the course of the historical process. That is why studying the reasons for the successes and failures of past federal systems can provide objective information about the direction in which modern federations will develop.

Participants: invited experts (with the possibility of a plenary report), young scientists and researchers (with and without reports).

### SESSION "FISCAL FEDERALISM AND SPATIAL DEVELOPMENT"

November 11, 2023 St Petersburg, Faculty of Law of St Petersburg University

The issue of organization of finances in the federal system is central to the discussion of the implementation of the competence of the federal and regional levels of government, thus affecting the real political situation of federalism. The extensive list of powers of the federation subjects does not guarantee them full autonomy from the federal level, and the increase in this list leads to an increase in the credit obligations of the federation subjects. On the other hand, excessive centralization of finances entails infringement of political rights of the federation subjects, which may result in a prolonged crisis. The search for ways to balance federal and regional budgets is the most important theoretical issue, which has applied significance in the context of overcoming the consequences of the COVID-19 pandemic, organizing regional integrations and in the reconstruction of war-affected regions.

**Participants:** invited experts (with the possibility of a plenary report), young scientists and researchers (with and without reports).

#### SESSION "REGIONAL INTEGRATIONS"

November 13, 2023

Moscow, International Law School, Moscow State Institute of International Relations of the Ministry of Foreign Affairs of Russia

Regional integration processes on the Eurasian continent have a long history and have long attracted the attention of scholars from around the world. However, with the diversification of the global economy and the emergence of a multipolar world, the experience of the European Union is beginning to be used by various integration associations on other continents. The adaptation of this experience to local peculiarities, as well as the growth of Euroskepticism prove the failure of the classical European view of integration processes. In turn, this requires the development of a general theory of regional integration based on the experience of regional integration associations in their comparative perspective.

**Participants:** invited experts (with the possibility of a plenary report), young scientists and researchers (with and without reports).

#### SESSION "COMPARATIVE FEDERALISM"

November 15, 2023

Moscow, International Law School, Moscow State Institute of International Relations of the Ministry of Foreign Affairs of Russia

Comparative federalism is the forefront of federalism research: the comparison of modern and historical federal systems greatly enriches the theory of federalism. The main problems of modern comparative federalism are the issues of the influence of regional, political and socioeconomic peculiarities on the institutional design of the federal system. Further study of federal systems from these points of view will make it possible to predict with a high degree of reliability the development of federal systems and regional integrations around the world.

Participants: invited experts (plenary report is an option), students (with and without reports).

Languages: English.

### SESSION "FEDERALISM IN LAW AND PRACTICE"

November 16, 2023
Moscow, Kutafin Moscow State Law University

The institutional design of the federal system is manifested not only in the declarative provisions of the constitution, but also in the institutional organization of power in the subjects of the federation and subnational legislation in various spheres. The study of the correlation between federal and regional legislation and law enforcement practice on various issues is not only one of the most important and complex issues in the study of federalism, but also the most vivid illustration of "living federalism".

**Participants:** invited experts (with the possibility of a plenary report), young scientists and researchers (with and without reports).

#### **CLOSING SESSION**

### FORESIGHT-SESSION: "FEDERALISM AND HUMAN RIGHTS"

November 17, 2023
Moscow, Kutafin Moscow State Law University

The crisis in international relations, caused by the aggravation of international armed conflicts and the strengthening of unilateral restrictive measures, directly affects the legal status and standard of living of people living in certain territories. Critical analysis of the status of individuals in such territories is unlikely to automatically solve all the problems of large groups of people who find themselves in a difficult life situation for political reasons, but it will help to eliminate high-minded and abstract rhetoric from scientific discourse. Federalism in its various forms has proven its usefulness as a means of solving hot and cold conflicts, connecting and disconnecting entire states, but can it improve the lives of ordinary people?

Participants: invited experts, young scholars and researchers (with and without papers).

Languages: Russian and English (simultaneous translation).


#### REQUIREMENTS FOR THE RESEARCH PAPER

- Not previously published and scientifically new;
- Office Word text file;
- Must contain the title of the paper, full name, author(s) information, e-mail address, abstract (100-150 words) and keywords (5-8 words) in Russian and English;
- 12 Times New Roman font;
- Single line spacing;
- Formatting of bibliographical references according to citation style Vancouver, page numbering under the main text;
- The paper should contain the title (title of the topic);
- The volume of the work: no less than 10 and no more than 60 thousand printed characters (with spaces);
- Originality: not less than 70%;
- At the end of the work a bibliographic list in Russian and English languages (up to 10 sources) is drawn up.


#### PLEASE NOTE!

- In case of non-compliance with the established rules (incomplete data about the author, exceeding the established volume of the paper, etc.) the Organizing Committee has the right to REVERSE participation in the conference.
- The Organizing Committee reserves the right not to specify the reasons for rejection of the papers.
- Co-authorship is allowed, but not more than three authors.
   When writing a paper in co-authorship, each author of the paper must submit an application for participation in the conference by filling out an electronic questionnaire.
- Any participant of the Conference may attend any session as a listener. Participation in the Conference is free of charge.
- Expenses related to travel to Moscow and St. Petersburg, accommodation and meals shall be reimbursed by the sending party.
- On the basis of the request of a full-time participant of the Conference, a personal invitation to the Conference may be issued on behalf of the Organizing Committee to compensate travel expenses in accordance with the procedure established by the sending party.
- It should be noted that the Organizing Committee does not facilitate the booking of apartments.


#### LOCATION




